- Use of any trademark logo from Platinum Producing Inc. or any site owned by Platinum Producing Inc. is strictly prohibited without prior consent in the form of signed consent from a representative of Platinum Producing Inc.

Affiliate Qualification Policy

- Platinum Producing Inc. reserves the right to approve, deny or discontinue business with any affiliate for any reason, at any time.
- Platinum Producing Inc. reserves the right to set required qualifications for potential affiliates on a case- by- case basis.

Payment Policy

- Platinum Producing Inc. will pay each affiliate according to a separate agreement made between the affiliate party and the representative of Platinum Producing Inc. The pay scale included in the agreement is binding once signed by representative of the affiliate party and Platinum Producing Inc.
- Platinum Producing Inc. will pay each affiliate on the 5th of every Month. Should this date change for any reason, Platinum Producing Inc. Is required only to notify those affiliates to whom payment is due
- The pay period is from the 5th of the month to the 4th of the next month.
- Commissions on continuity will be paid only on customers who successfully re-bill after 30 days. The selling affiliate will receive continuity commission on the next pay date, only for those customer(s) who re-bill.
- Affiliates who receive residual income from each re-billed customer are to be paid each time that customer re-bills.
- Only customers who re-bill will qualify the selling affiliate for incentives, and rise in the pay scale.
- Each time an affiliate jumps on the pay scale, the commission increase will apply to each customer who re-bills as of the date the increase is reached. This includes previously existing customers.
- Affiliates will only be paid on successfully re-billed customers. Based on the volume of re-billed customers, the affiliate may move up or down the pay scale for any given month. This could mean an affiliate could make more or less commission on any given month.

Cookie Policy

- Platinum Producing Inc. reserves the right to use cookies for affiliate tracking purposes.
- Our cookies are set to not expire, but Platinum Producing Inc. is not responsible should the cookie no longer function for any reason.
- If the cookie is replaced by another affiliate referring the same customer, it is up to the two affiliate parties to resolve the matter on their own.
- Affiliates of Platinum Producing Inc. may **not** use parasiteware for any reason.
